When signing it into law, President Obama admitted he had reservations about its contents. > Change of EP Elections Policy

Recently, the Ministry of the Interior of The Netherlands informed the Dutch Parliament that it would change its policy on the moment of publication of results of the elections for the European Parliament. In her letter of 8 February 2012 Minister Spies stated that The Netherlands will in the future release these results only after ballot-boxes in all EU member states have been closed, and no longer at the end of the day EP elections are held in The Netherlands. In this way, The Netherlands falls into the fold of the general European rule. The decision is also in line with recommendations made by the T.M.C. Asser Instituut in 2008 in an EUwide research project carried out for the European Commission on how Member States implemented the so-called Election Act. One of the study's key findings, on the irregular way of implementing EU rules on publishing EP election results, was further scrutinised in an article by Leendert Erkelens, published in the May 2009 issue of SEW. In her letter to the Dutch Parliament, Minister Spies explained that thanks to the modification of its publication policy of EP election results The Netherlands would be spared from an infringement procedure initiated by the Commission.
