Overview

After the success of the first editions in 2022 and 2023 the programme returns, focusing on the **link between the sport and human rights** and zooming in on a number of topics, such as the UN Guiding Principles for Business and Human Rights and their application in sports. We will also adopt a human rights lens to sport governance and address freedom of speech, the rights of athletes, and access to remedy.

The programme brings together **the latest in academic research with practical experiences from working in the field** in an interactive package, fostering productive exchanges between the speakers and participants. Theoretical knowledge will be complemented by exposure to handson know-how and exercises. Participants will have the opportunity to learn from experts from the Asser Institute and the Centre for Sport and Human Rights, as well as high-profile external speakers from both academia and practice.

This summer law programme, co-organised with the War Crimes Research Office of American University's Washington College of Law, focuses on **international criminal law and the legal aspects of counter-terrorism.**

In this unique training programme, selected students from top US law colleges and universities will learn from internationally renowned legal practitioners and scholars. Additional places are available to other interested law students and professionals who wish to learn more about international criminal law and legal aspects of counter-terrorism.

Overview

Since 2019, the Asser Institute offers a week-long academy on the theory and practice of sustainability due diligence as master key to responsible business conduct. The academy features expert lectures from academics in the field and practical sessions led by experienced practitioners from both the private and public sectors. Over the past five editions we have trained more than 100 participants from all around the world, who are contributing in the public and private sector to the implementation of the sustainability due diligence revolution.

In 2024, we are offering a newly developed edition of the spring academy dedicated to the technologies of sustainability due diligence. Practitioners and academics will critically reflect on the role of digital technologies in the governance of global value chains through the sustainability due diligence process.

The training will blend theory and practice through a combination of lectures delivered by academics and workshops with practitioners aimed at explaining the function and functioning of specific technological solutions in the context of the due diligence process.

Overview

The spring academy on artificial intelligence and international law is an innovative one-week training programme, launched in 2019. The programme will provide you with insights into the current and future issues raised by AI technologies from the perspective of international law and related disciplines.

The spring academy offers in-depth knowledge and perspectives on AI and international law. It addresses fundamental issues at the intersection of theory and practice, and provides a platform to engage with the diverging perspectives in the key emerging debates. The programme is structured around five themes: understanding AI, AI and human rights, AI in warfare, current challenges, and international governance of AI.

The programme's sessions are delivered by experts in the field, both from academia and from practice. The programme is updated each year to feature latest developments and new research in the field.

Overview

The threat posed by nuclear, chemical and biological weapons has reached levels of urgency not seen since the Cold War. There is a growing demand for professionals with the necessary legal, technical and policy expertise to tackle the challenges of today's non-proliferation and disarmament agenda. Join us for the fourteenth training programme on disarmament and non-proliferation of weapons of mass destruction, co-organised with the Organisation for the Prohibition of Chemical Weapons (OPCW).

During this intensive training programme, you will receive a comprehensive overview of the international non-proliferation and disarmament framework. You will learn from renowned experts and practitioners in the field and engage in active discussions about key topics and current debates. Lectures will be complemented by field visits to the Nuclear Reactor Institute Delft, the OPCW Laboratory and Equipment Store, and the OPCW headquarters. The programme also provides you with the opportunity to build your professional network with experts in the field, as well as with your fellow participants.
